- Completion of S6 under the new academic structure plus pass grade in HKDSE Mathematics, Physics and Technical Drawing**; and with one year relevant working experience; or
- Completion of S5 under the old academic structure plus pass grade in HKCEE Mathematics, Physics and Technical Drawing**; and with one year relevant working experience

Mature applicants, i.e. those aged 21 or above with at least two years' relevant working experience, may be admitted. Where appropriate, the applicant may be required to pass an entrance assessment, which can be in an oral and/or written form. Plus, fulfilling the qualification in Plumbing Mathematics, Plumbing Science and Construction Drawing**.

**Applicant without the qualification in Plumbing Mathematics, Plumbing Science and Construction Drawing must complete the bridging modules (code: 1735, 1736 & 1737).
